

Analysis of Sexual Behavior of Prisoners in Correctional Facility

ABSTRACT

Inmates have a tendency to vent their sexual needs by having sex with a friend such as by way of oral sex, anal sex, and masturbation. The purpose of this study is to determine sexual behavior in inmates in the correctional institution in Kediri. The research uses qualitative research design with a phenomenological approach. The data collection uses techniques in-depth interview on 5 informants with Snowball Sampling. The results of this study showed 6 analysis of sexual behavior that inmates in the town of Kediri, namely 1) the perspective of sexual behavior by inmates, 2) factors affecting the deviation sexual behavior, 3) sexual behavior inmates, 4) the impact of deviations in sexual behavior by inmates, 5) efforts to prevent disease due to irregularities prison sexual behaviors, 6) variations of sexual behavior of prisoners. Inmates in prisons, their sexual needs are not freely fulfilled as at home so that it effects on sexual behavior. Therefore it needs to do positive activities such as improvement of skills, sport, art and religion so that the prisoners can avoid sexual misconduct.

INTRODUCTION

Inmates are convicts serving the criminal lost independence in Prisons (Law No. 12 of 1995). Inmates are they put into a holding cell and undergo punishment according to the crime committed. After undergoing trial proceedings they become prisoners.

According to Donaldson in Wahyuni [1] says that inmates have a tendency to vent their sexual needs by having sex with a friend of the same sex in a way oral sex, anal sex, and masturbation that sexual behavior is limited to pronunciation and conversation about sex. Wooden & Porker in Wahyuni [1] says 50% of heterosexual inmates engage in sexual activity with the same sex (homosexual) during languishing in prison. Based on the results of research conducted at the Correctional Institution Tanjung Gusta Medan in 1999 by Brahmins [2], obtained information that the inmate in fulfilling their sexual needs while in prison, they perform sexual practices in the form of masturbation (68%), anogenital and orogenital (32%) [3].

Data from each office of the ministry of law and human rights special areas of the republic Indonesia capital Jakarta there are 108.922 103.128 inmates consisting of adult male prisoners - male, female adult prisoners 5.794. While data from the regional office of East Java ministry of law and human rights republic of Indonesia there are 10.003 inmates, consisting of 9.456 inmates' adult males, 547 adult female inmates. While in prison class II A Kediri there are 456 inmates consisting of 441 adult male inmates, 15 inmates' adult women [4].

Based on the preliminary study investigators on April 18, 2016 penitentiary class II A Kediri, obtained from interviews with four inmates in prisons class II A Kediri in getting the results that the two inmates who are married say they actually want to have sex but of the prisons are not allowed and there is no room or facility for sexual intercourse, two inmates were not married say thinking about sexual relationships exist but they do not have a partner and there is no place to do it in a correctional institution so they vent with activities that is in the penitentiary. One of four inmates say there are some inmates who have a deviant sexual behavior as homosexuals.

At inmates, expression and sexual fulfillment experience barriers to distributed, these conditions will affect the tendency of the sexual behavior of prisoners. In this case the biggest problem inmates especially on inmates who are married are sexual needs. At the time of the inmates are in prison is certainly not free sexual needs met at home so the effect on sexual behavior. Behavior is the body's response to a stimulus or

individual actions that can be observed and have the specific extent, duration and destination either consciously or unconsciously by a person [5].

Deviant sexual behavior is a behavior that should not have happened. Therefore the prisoners to avoid sexual misconduct can implement activities towards a positive direction so that the inmates can avoid sexual misconduct.

Based on the above, the researcher is interested in conducting research on "analysis of sexual behavior in inmates in prisons class II A Kediri".

RESEARCH METHODS

The research design used in this study is a qualitative approach from the standpoint of phenomenology. This method is done by a descriptive survey to describe or illustrate a phenomenon that occurs [6]. In this study, exploratory character and there is no treatment to the subject of study, aims to describe (explain) the important events that occur in a systematic and more emphasis on factual data about the state of the object that is sexual behavior in inmates at the Correctional Institution Class II A Kediri. The research subject is a generalization region consisting of an object or a subject that has a certain quantity and characteristics defined by the researchers to learn and then drawn conclusions, so that qualitative research does not use the term population [7]. Subjects in this study were inmates at the penitentiary class II A Kediri some 25 prisoners. Informants in this study are inmates at the Correctional Institution Class II A Kediri five informants. Engineering samples in this study is the snowball sampling is a technique determination of sample chain of participants to other participants.

RESEARCH RESULTS

1. Perspective of Sexual Behavior According Inmates in Prison.

Themes perspective of sexual behavior by inmates in a can of special purpose explores how sexual behavior in inmates in prisons class II A Kediri could happen to do an interview on inmates in prisons class IIA Kediri. Divided into two sub-themes, namely the understanding of sexual behavior by participants and differences in sexual behavior with sexual according to participants as follows:

"Of course the sexual behavior is not good, not good with other wives, it is good with their wives in the terms of the religious rules" (informant 1)

2. Factors Affecting Sexual Behavior Deviation

Scene deviation factor affecting sexual behavior by inmates in the special purpose dactri can explore the factors that influence sexual behavior in inmates in prisons class II A Kediri could happen to do an interview on inmates in prisons class IIA Kediri. Divided into five sub-themes, namely the facility for sexual intercourse is not there, unfulfilled desire to have sexual relations, economic factors, the urge to have sexual intercourse, deviant association as follows:

"Yes humane there are, but how else there is no partner he he he "" Yes, how can I , so I diverted to activities within the prison, but yes I sometimes think about things like that "(informant 4)

3. Sexual Behavior What Do Inmates

The theme of sexual behavior inmates can from special purpose explores the types of sexual behavior in inmates in prisons class II A Kediri by interviewing the inmates in prisons class IIA Kediri. Divided into two sub-themes, namely sexual behavior while in prison, how venting time in prison as follows:

"Yes it is common for men if there is no impingement, do masturbation "(informant 5)

4. The impact of sexual deviant behavior by inmates

Scene deviation impact sexual behavior by inmates in a can of special purpose exploring the impact of sexual behavior in inmates in prisons class II A Kediri by interviewing the inmates in prisons class IIA Kediri. Divided into two sub-themes, namely as a result of sexual behavior that is unnatural inmates and disease caused the negative sexual behavior as follows:

"Yes, if it is not reasonable it can be illness, tend to be not good, sometimes indulge yourself and that's all" (informant 4)

5. Efforts to prevent disease due to irregularities prison sexual behavior

Themes effort prisons prevent diseases caused by sexually deviant behavior by inmates in a can of special purpose Exploring the impact of sexual behavior in inmates in prisons class II A Kediri by interviewing the inmates in prisons class IIA Kediri. Divided into 1 sub themes, namely screening of sexually transmitted diseases as follows:

"There is an HIV/AIDS check for blood, not routine, usually at the beginning to enter custody only for checking" (informant 4)

6. Irregularities sexual behavior of prisoners

The theme of sexual misbehavior inmates by inmates in the can of special purpose explores the types of sexual behavior in inmates in prisons class II A Kediri by interviewing the inmates in prisons class IIA Kediri. Divided into two sub-themes, namely inmates and sexual behavior of homosexual inmates in prison as follows:

"As long as I know they like each other, girl with girl, it is lesbian" (Informant 4)

DISCUSSION

1. Perspective of Sexual Behavior According Inmates in Prison

Based on the statement of comprehension or understanding of sexual behavior according to the informant in prison. Informants said that sexual behavior is a behavior that is not good, a pleasure, sexual intercourse and a desire to have sex freely. In the fifth informants statement above it is clear that the informant had each other's perceptions in their understanding of understanding so that they can form their opinion there are differences in sexual behavior with sexual, but also there are lumped together. It is evident from the statements of all informants: 3 informants assume the same while the two informants assume different between sexual behaviors and sexual. Sexual behavior is the behavior of all forms of behavior that is driven by sexual desire is well done with the opposite sex or with sesame types. Forms of this behavior starts assortment of flavors interested, dating, flirting to intercourse [8].

2. Factors Affecting Sexual Behavior On Prisoners

In terms of the factors that influence sexual behavior inmate informant is no facility for sexual intercourse, sexual desire and their supporters did sexual behavior, the urge to perform sexually, socially deviant. This is evident in the explanation of all informants stated the same thing that the factors which influence sexual behavior backs in terms of facilities ie no facilities sexual needs, if any, they will take advantage of it.

According to the informant statements about factors that affect sexual behavior in prison is not the fulfillment of a desire to have sexual intercourse. The informant stated there and has the will and claimed never to vent. Often stripped, but there is no impingement, wants sexual intercourse but cannot take it, while the two informants expressed a desire to have sexual intercourse but no opponent to do.

Statement by the informant at factors that influence sexual behavior are at their motivating factor for sexual intercourse three informants state that lust is the most influential factor in sexual behavior. While the social factors that deviate in other informant stated environmental social factors influence sexual behavior. Sexuality is experienced and expressed one through sexual attitudes. Sexual attitudes someone will influence the decision and chosen form of sexual behavior [9,12].

3. Sexual Behavior What InmatesDo

Inmates' sexual behavior as unexplored, namely sexual behavior while in prison, sexual behavior before entering prison, how venting in prison In this case each informant has a different behavior in prison sexual behavior during the informant claimed not never done her long as in prisons and a prison informant during declare masturbation to satisfy themselves. Sexual behavior is also reflected in the form of venting, the informant claimed never to vent during a prison, unlike the case with three other informants stated vent with masturbation while in prison.

4. Impact of Sexual Behavior Deviations According to Prisoners

Based on the statements of informants about the impact of sexual behavior in inmates be due to unusual sexual behavior and the disease caused. The statements of the four informants indicates common statement that infectious diseases, while one informant stated unusual sexual behaviors impacting go to jail and could not gather the same family. In their exploration of all informants disease caused by sexual behavior is negative, all the informants said the same thing. According to Donaldson [10] that inmates have a tendency

to vent their sexual needs by having sex with a friend of the same sex by way of oral sex anal sex, and masturbation that sexual behavior is limited to pronunciation and conversation about sex.

5. Efforts to Prevent Disease Due Deviation Prison Sexual Behavior

Based on the statements of four prison informants about efforts to prevent diseases caused by food-Depository sexual behavior. According to the prison informant did screening infectious disease carried on the initial entry and one informant stated prisons every month three times the examination.

6. Irregularities Prisoners Sexual Behavior.

Results informant interviews on all the types of sexual behavior of prisoners may be deviation explored sexual behavior of prisoners that homosexual (gay and lesbian) and sexual behavior of prisoners in prisons. Statement of their deviant behavior (gay) provided by three informants, while the deviation of sexual behavior (lesbian) is expressed by the prison informant that there are lesbians. Another thing that there are deviations in sexual behavior also occurs in prison inmates who have been expressed by three informants to satisfy themselves with masturbation.

The prison system which is a place of detention and guidance for inmates is characterized by sexual segregation in which placement is based of the same sex, so that interaction is the interaction between the same sex. One of the impacts of prisoners are prisoners deprived of the opportunity for sexual intercourse resulted prisoners must create a separate mechanism for them in order to address growing sexual needs are often the mechanisms embodied in deviant sexual behavior [10,11].

CONCLUSION AND RECOMMENDATION

Conclusion

1. Perspective of Sexual Behavior According to inmates in correctional Institution is sexual behavior by inmates' deeds sexual intercourse, and according to some informants is deviant behavior.
2. Factors Affecting Sexual Behavior In The prisoner is not their facility so it cannot make or distribute desire sexual intercourse, most informants stated that affect appetite, as well as the environment but also there are triggering factors such as money, HP and their temptations.
3. In a type of sexual behavior, a form of impingement there are differences from the other informants how to satisfy themselves such as masturbation, some are never done
4. The impact of sexual behavior by inmates in the form of diseases such as HIV / AIDS or other infectious diseases
5. Efforts to Prevent Disease Due to Irregularities Prison Sexual Behavior by inspecting reflecting efforts to prevent the spread of HIV / AIDS, the inmates get a check HIV / AIDS in prisons and also the initial entry every month three times. Examination by the inmates of prisons on a regular basis as well as directly entered prison when this is done to ensure prisoners' health conditions of the potential spread of the HIV virus as well as the prevention of the spread of the disease in order not to spread and infect other prisoners for living together in a prison environment.
6. The impact of sexual behavior in inmates in general form of the disease. Deviations inmate sexual behavior is homosexual (gay and lesbian) and sexual behavior of prisoners in prisons in the form of pleasuring herself "masturbation". Deviations same-sex sexual behavior in order to address inmates' sexual needs and desires that grow are displayed in deviant sexual behavior because inmates feel deprived of the opportunity for sexual intercourse.

Suggestion

1. For further research

We hope this research can be information for further research to study and know the analysis of sexual behavior in prisoners and can continue research titled psychological impact for prisoners who have sexually deviant behavior in prisons class II A Kediri

2. For the institution where the research

In human intercourse is very necessary, for the prevention of sexually deviant behavior held to have sexual intercourse facility specifically for inmates who are married to legally and religion. Or screening examination should be carried out not only when inmates early entry, but must be done every month and when the prisoners will get out of prison.

3. Educational institutions

Expected results of this research into the repertoire of literature and information and can also as a reference for future research.

4. For the people

People should be given an overview of how forms of sexual behavior of prisoners, so that the community can understand the sexual behavior of the inmates.

5. Informant

Preferably informant sexual behavior appropriately, and transfer the activities in prisons so that no irregularities occur in the sexual behavior of prisoners.
